PRODUCT INFORMATION

DynaGold Corn Mix is a liquid foliar formulation designed to correct and prevent Zinc and selected deficiencies in corn and other crops. If added to the spray tank first, **DynaGold Corn Mix** will aid in lowering the water pH. A jar-test to check the compatibilities of new or unfamiliar chemical combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and /or urea nitrogen will aid in uptake.

DIRECTIONS FOR USE

DynaGold Corn Mix should be applied at weekly intervals starting with the first spray at 1 to 2 quarts per application in enough water to cover. Aerial application: 1-1½ quarts per acre in a minimum of 5 gallons of water.

CROP RECOMMENDATIONS

Corn and other crops requiring high Zinc: Use 1 to 2 quarts per acre in a minimum of 5 gallons of water per application.
